

Free Wireless Router When You Order HughesNet Online with Acme Satellite

Receive a wireless router by mail when you order HughesNet online through Acme Satellite. Service must be ordered between 01/01/2009 and 01/31/2009, directly from www.acmesat.com. All submissions must be received by 04/1/2009.
